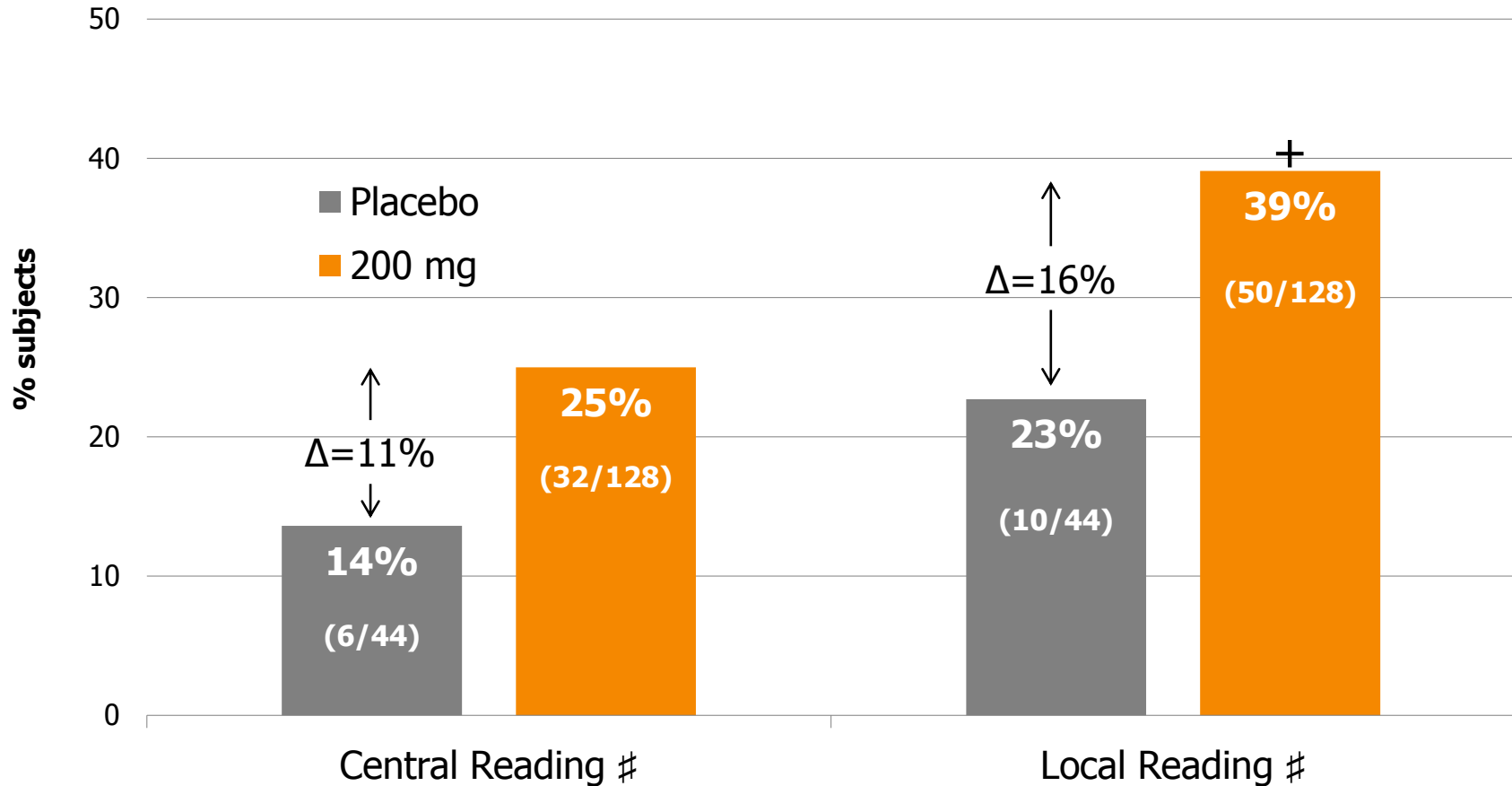

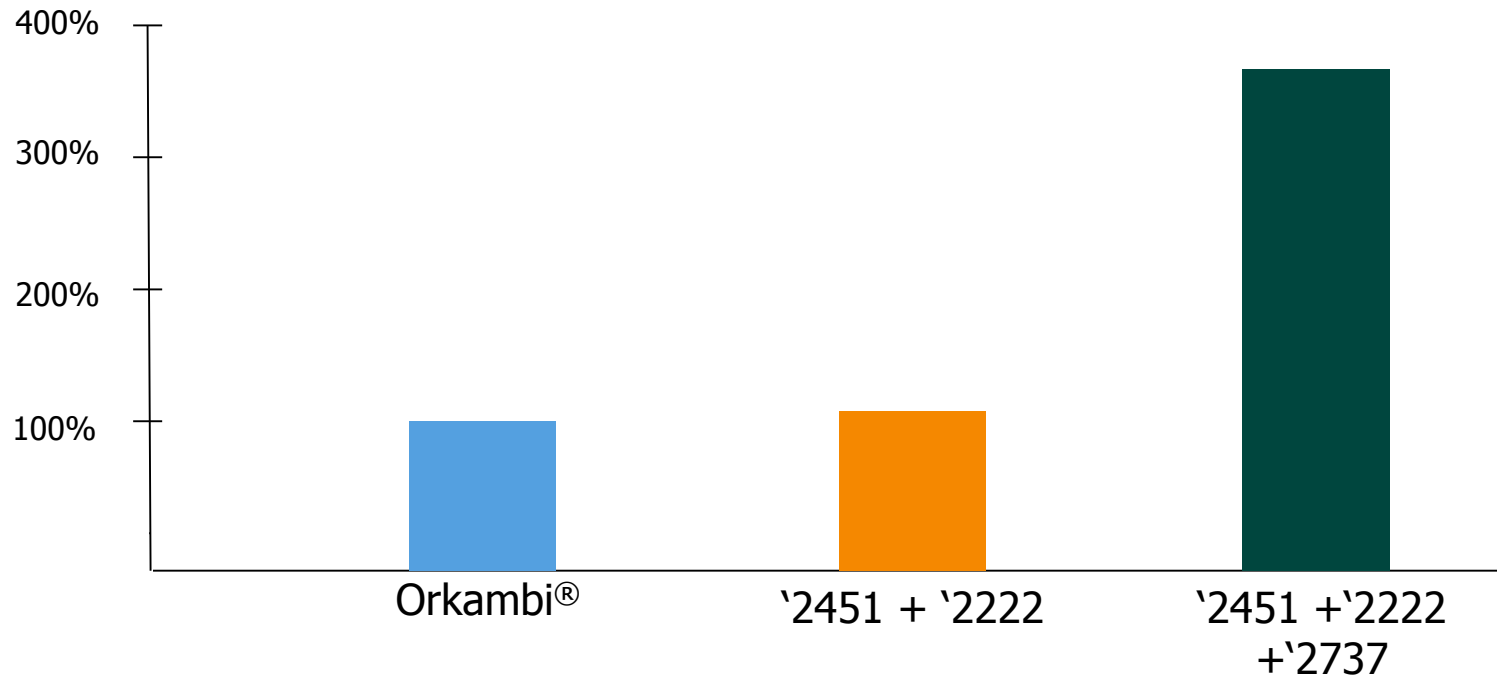

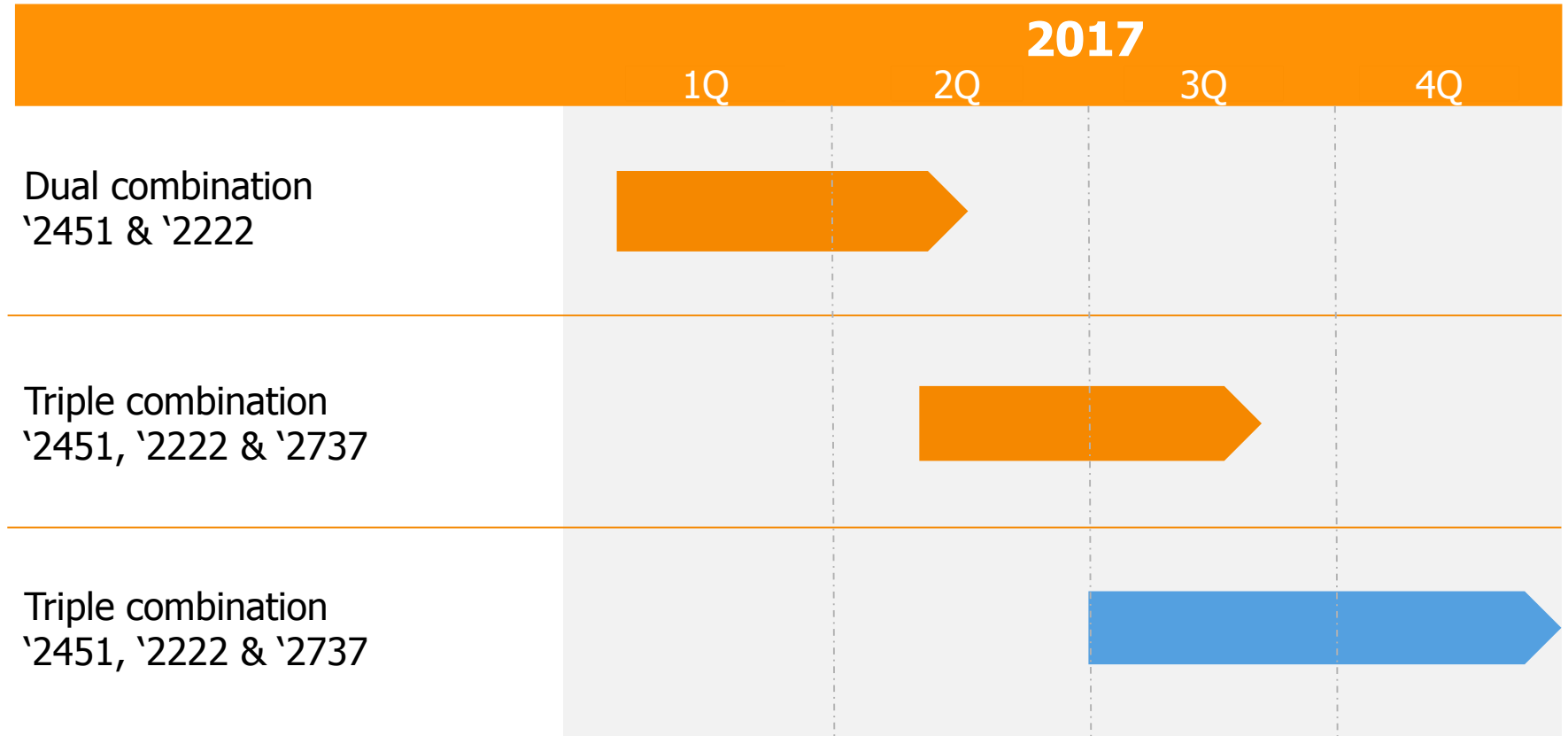
% of dual combo

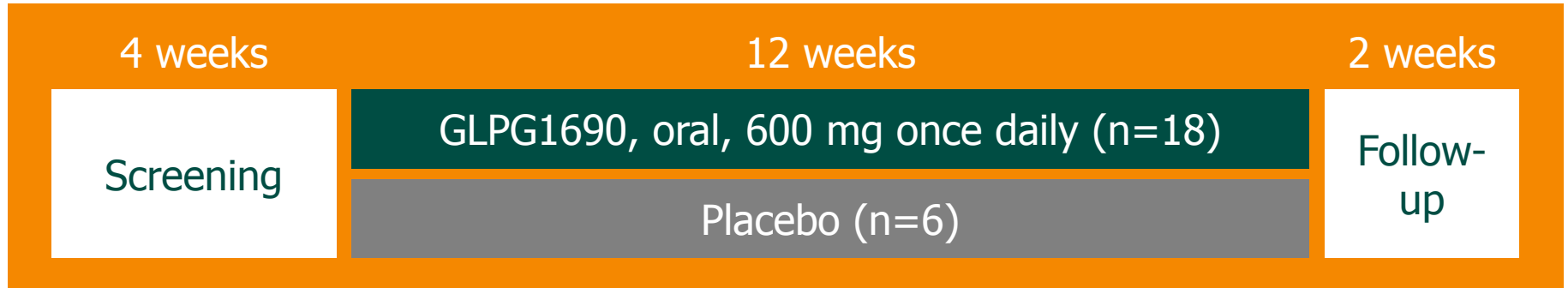

# FLORA: topline H2 '17

GLPG1690 exploratory Ph2a study in IPF



- IPF patients diagnosed by HRCT/biopsy, centrally confirmed
- No pirfenidone/nintedanib 4wks prior to screening
- 17 sites in UK, Italy & Ukraine
- Primary endpoints: safety, tolerability, PK/PD
- Secondary endpoints: FVC, QoL, FRI, serum & BALF biomarkers

FLORA is fully recruited

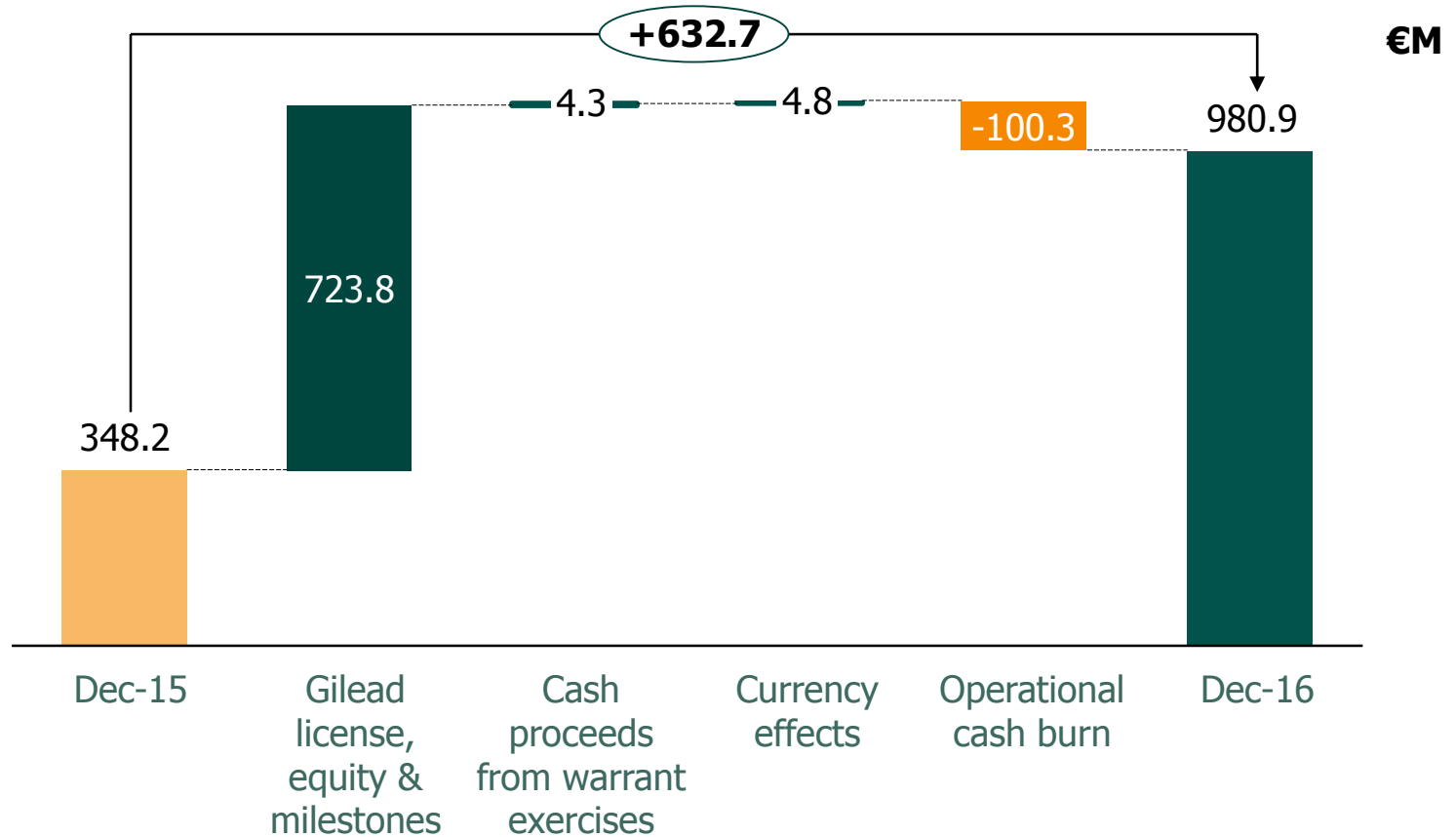

Cash burn in line with guidance, ≈ €1 B in cash

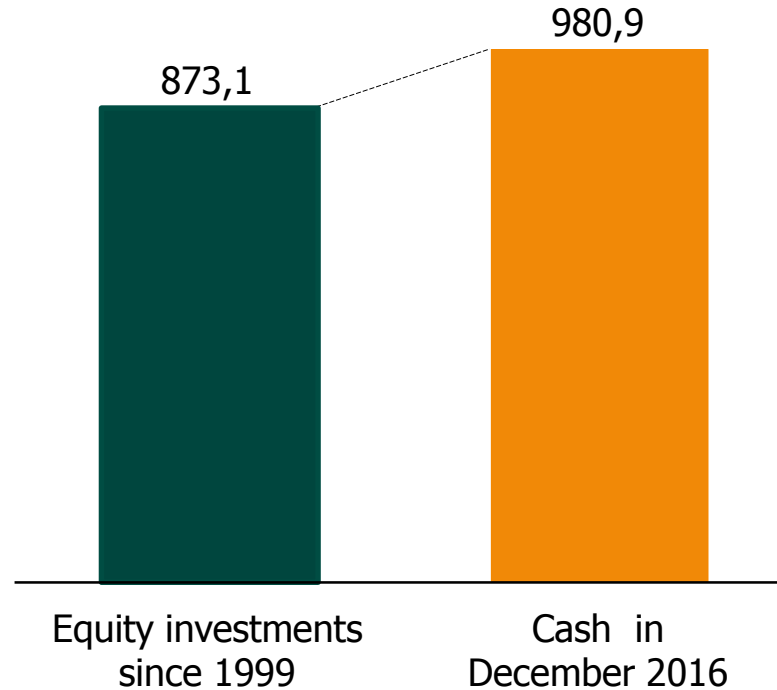

# Cumulative cash since inception

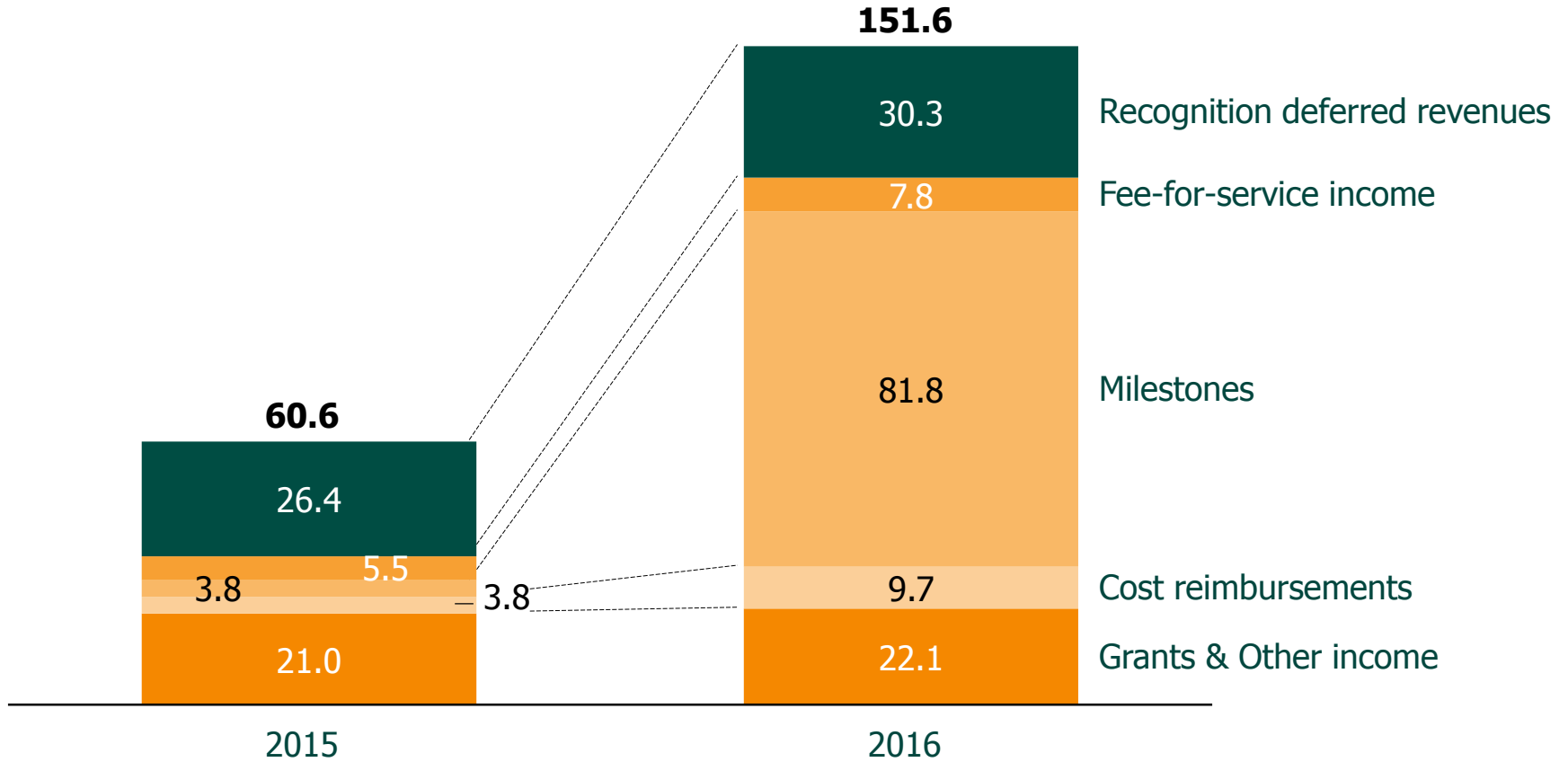

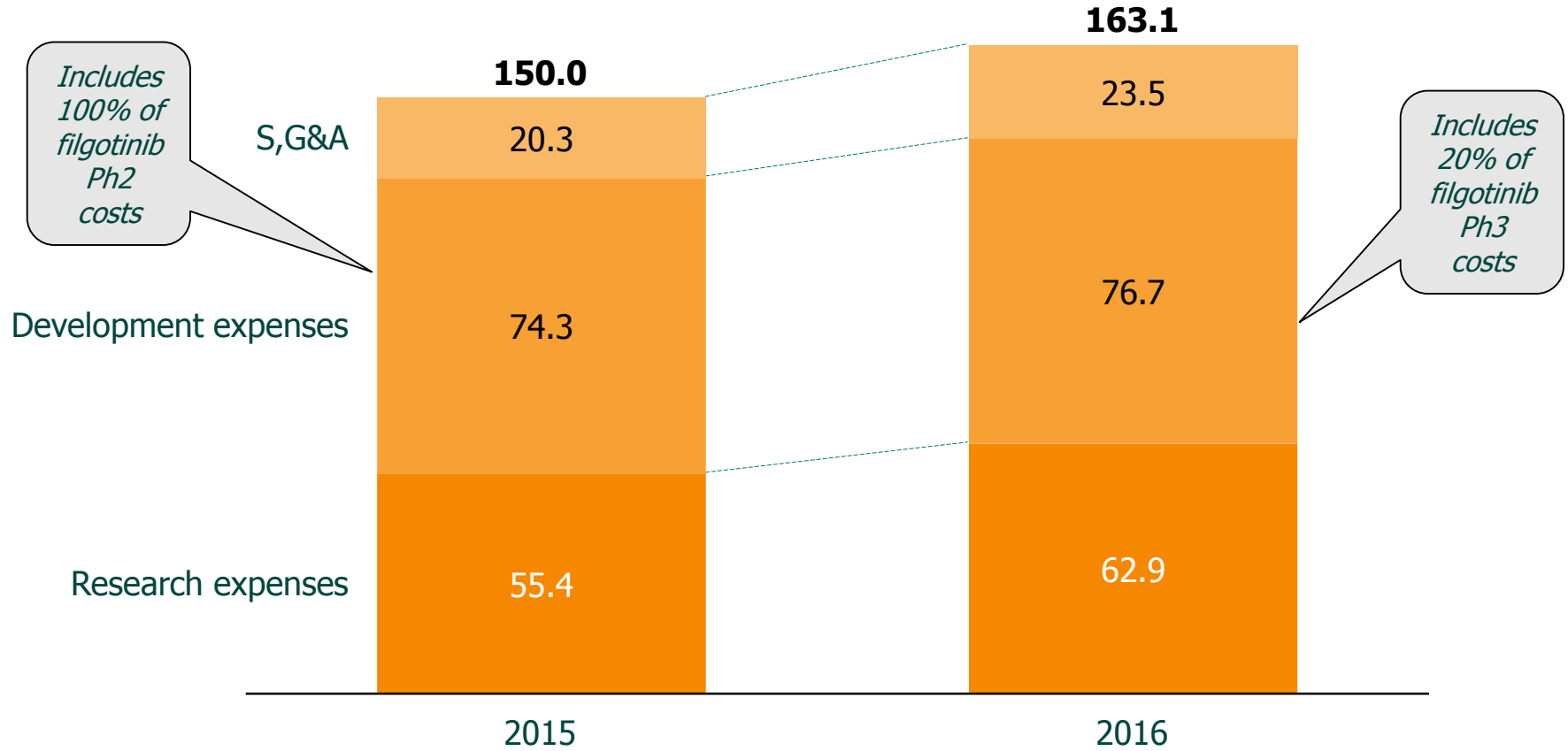


Milestones from our filgotinib and CF alliances drive revenue increase





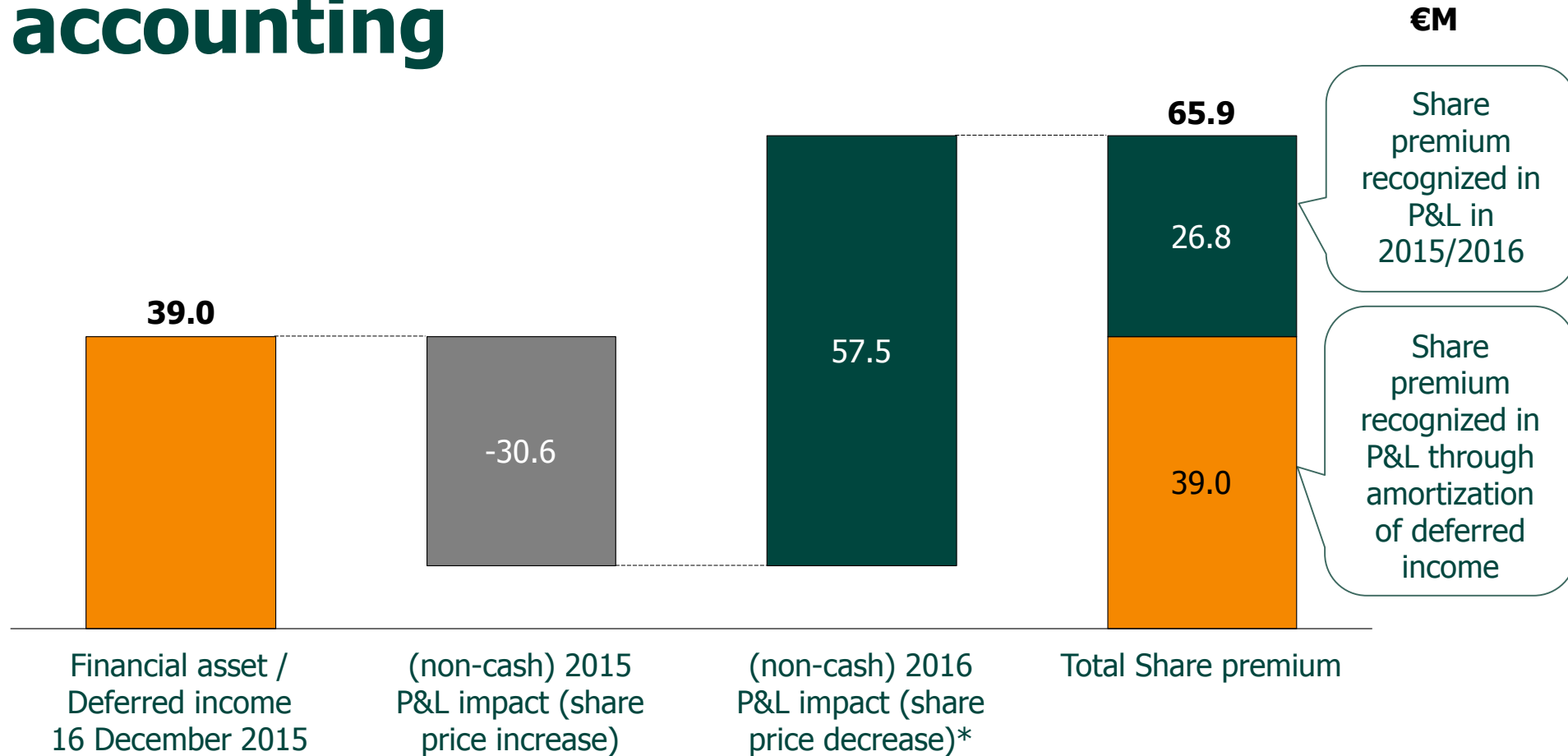
# Operating expenses

# (non-cash) Financial asset accounting



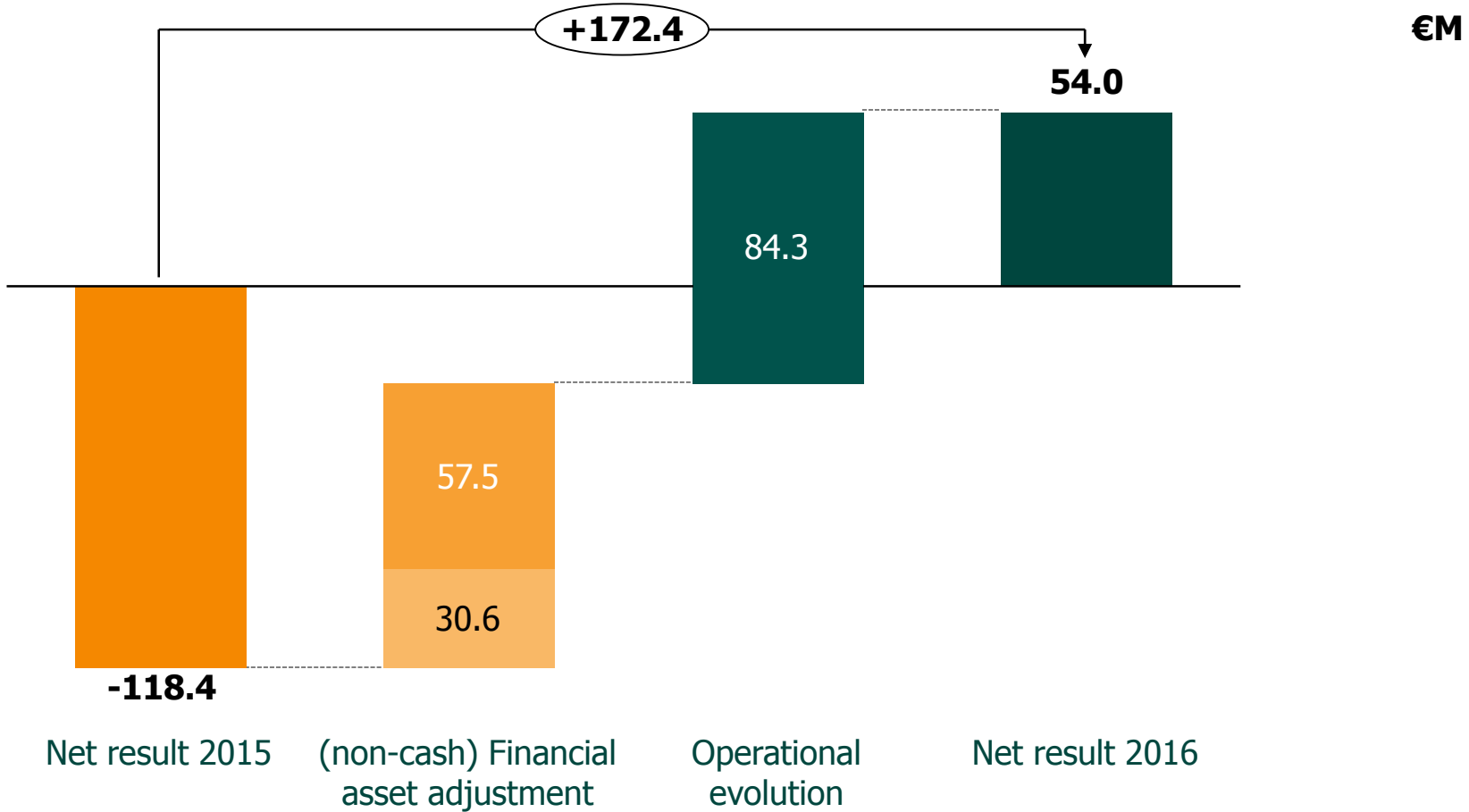
Share premium of €66m to be recognized in P&L over time
